City Commission meetings are <u>streamed live on the internet and broadcast live</u> from the Commission Chambers Room 206 the first and third Tuesday of each month beginning at 7:00 p.m., and re-aired the following Wednesday morning at 10:00 a.m., and on the second and fourth Tuesday nights of each month at 7:00 p.m.

Cascade County Commission meetings are regularly held at the Courthouse Annex the second and fourth Tuesday of every month at 9:30 a.m. View the <u>Board of Cascade County Commissioners 2014 meeting schedule</u>. The video recorded meetings are aired on City-190 Wednesday at 7:00 p.m. and Thursday at 10:00 a.m. the week of the meeting, and Wednesday at 7:00 p.m. during the off weeks.

If there are agenda items, the Planning Advisory Board/Zoning Commission meetings are <u>broadcast live and</u> <u>streamed live</u> on the second and fourth Tuesday of each month beginning at 3:00 p.m., and re-aired the following Thursday at 7:00 p.m. Check the <u>Boards and Commissions page</u> for meeting cancellations.

The Board of Adjustment/Appeals meets on demand. The meetings are usually scheduled for Thursdays at 3:00 p.m. These meetings are also <u>broadcast and streamed live</u>, and re-aired the following Friday morning at 10:00 a.m. Check the <u>Boards and Commissions page</u> for scheduled meetings and cancellations.
