

ORDINANCE NO. 2904

AN ORDINANCE ASSIGNING A ZONING CLASSIFICATION OF "C" RESIDENCE USE, "C" AREA DISTRICT, FOR BEEBE TRACTS 11-1 AND 11-2, IN SECTION 9, TOWNSHIP 20 NORTH, RANGE 4 EAST, P.M.M., CASCADE COUNTY, MONTANA

WHEREAS, Western National Properties, Inc., has petitioned the City of Great Falls to annex Beebe Tracts 11-1 and 11-2, located in the NE1/4 of Section 9, Township 20 North, Range 4 East, P.M.M., Cascade County, Montana; and,

WHEREAS, Western National Properties, Inc., has petitioned said Beebe Tracts 11-1 and 11-2, be assigned a City zoning classification of "C" Residence District, "C" Area District, upon annexation to City; and,

WHEREAS, notice of assigning a zoning classification of "C" Residence Use, "C" Area District, to said Beebe Tracts 11-1 and 11-2, was published in the Great Falls Tribune advising that a public hearing on this zoning designation would be held on the 5th day of April, 2005, before final passage of said Ordinance herein; and,

WHEREAS, following said public hearing, it was found and recommended that the said zoning designation be made, NOW THEREFORE,

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF GREAT FALLS, STATE OF MONTANA:

Section 1. That the zoning of Beebe Tracts 11-1 and 11-2, be designated as "C" Residence Use, "C" Area District classification.

Section 2. This ordinance shall be in full force and effect either thirty (30) days after its passage and adoption by the City Commission and approval by the Mayor or upon filing in the office of the Cascade County Clerk and Recorder the resolution annexing Beebe Tracts 11-1 and 11-2, into the corporate limits of the City of Great Falls, Montana, whichever event shall occur later.
